

>>> RESOURCES

The backbone of CampDoc / SchoolDoc, the <u>List Builder</u> is a powerful tool that allows you to filter your Profile List to a subset of profiles that match specific criteria. You can filter for just about anything by adding one or more <u>conditions</u> (specific elements of a filter), including profiles with answers to specific questions asked in your Health Profile.

>>> CHART MEDICATION
